Approval of the June 13, 2019 Meeting Minutes- Motion to approve the Loss Control meeting minutes, Executive Committee and Executive Session meeting Minutes was made by Maryellen Brennan and seconded by John Hatzelis and passed unanimously.

3. Treasurer's Report

a) The July 11, 2019 Bill List was presented totaling \$522,365.05. Motion to approve the Bill List was made by Maryellen Brennan and seconded by Bill Eagen. A roll call vote was taken, the motion passed unanimously. Rich Phelan abstained on the Clinton Town Grant payment. b) Treasurer's Report as of May 31, 2019 was presented by Marvin Lusbader. A motion to accept the Treasurer's Report was made by Rich Phelan and seconded by Bill Eagen. A roll call vote was taken, the motion passed unanimously.

4. Discussion Items

A. Medlogix Savings Report – June 2019

The report included in the agenda kit was reviewed by Missy Pudimott.

B. Administrator's Report

- Caroline Conboy discussed Senate Bill S-2432, known as the Haines bill, passed in both houses. S-2432 overturns the Supreme Court's decision in Haines and would allow for uncompensated medical expenses resulting from an auto accident to be included in a claim without the application of the PIP fee schedule. It could also permit attorney fees to be included as a part of the damages.
- Governor Murphy signed a new law that reforms New Jersey's workers' compensation law to create a rebuttable presumption of coverage for public safety workers for certain illnesses. For firefighters, those with seven or more years of service who suffer an injury, illness or death caused by certain types of medical conditions would not be required to demonstrate causation or exposure before receiving medical benefits and financial compensation. Other first responders, including first-aid or rescue squad members, police, corrections officers, nurses, medical technicians, and other medical personnel, are also not required to demonstrate causation of illnesses, but are required to provide evidence of exposure. Members will have to become compliant with rosters and documentation. It is hard to determine the impact on any funding levels at this point.
- Caroline Conboy advised the Certificate of Insurance received from Olmezer Appraisal Service, one of the Fund's automobile appraisal vendor's, that shows they are insured with a risk retention group, an organization similar to the Fund. A motion was made to accept the COI by Bill Eagen and seconded by Rich Phelan. A roll call was taken.
- The State of New Jersey DOBI Audit started on July 1, 2019.
- The submission for the Excess Property coverage has been submitted to the market for quotes.
- The Markel Grant with be used for additional risk services, such as the driving simulator.
- Five CD's with Valley National Bank matured last month and the investment committee approved the renewal for 18 months at the rate of 2.10%.
- C. Resolution EC #19-33 Extending Safety and Loss Control Provider. A motion was made to approve Resolution EC19-33 by John Hatzelis and second by Bill Eagen. Roll call was taken.
- D. Resolution EC #19-34 Extending Contract with Enquiron. A motion was made to approve Resolution EC19-34 by Rich Phelan and second by Matt Hall. Roll call was taken.
